





I live with an invisible disability and am the parent of two boys, including my youngest son, who was diagnosed with Autism Spectrum Disorder at the age of three. These experiences have shaped my lifelong advocacy for equity, diversity, and inclusion, both personally and professionally.

I strongly believe in the importance of the work VAD Society is doing and in the opportunity we have to further advance accessibility across Alberta. By working collaboratively with community partners, employers, government representatives, and service providers, we can continue to reduce barriers and support meaningful, sustainable accessibility across workplaces, programs, services, and community spaces throughout the province.

I am excited to bring my lived experience, professional background, and passion for giving back to my community into this role, and I look forward to working alongside you to strengthen accessibility and inclusion for Albertans with disabilities.

## Alberta Disability Assistance Program

The Alberta Disability Assistance Program (ADAP) will provide financial, health and personal supports to Albertans with permanent and short-term disabilities who are able to work.

### Purpose

The Alberta Disability Assistance Program (ADAP) will empower Albertans with disabilities to pursue fulfilling job opportunities while continuing to receive the financial, medical and personal supports they need.

Albertans with disabilities and the organizations that support them have made it clear that they want supports that meet their unique needs and abilities, rather than the current one-size-fits-all solution offered by the long-standing Assured Income for the Severely Handicapped (AISH) program. Albertans with disabilities stressed the importance of providing pathways to employment for individuals who are able to work but still need to receive benefits, and AISH is not designed to provide this type of support.

ADAP is being thoughtfully designed based on input from Albertans with disabilities to address a gap in supports for individuals with disabilities who are able to work and want to enjoy the benefits that come with employment, such as earning a pay cheque, building relationships, developing skills, and providing a sense of purpose, belonging and independence.

### How it works

Albertans on ADAP will also have access to the resources and tools they need to gain new skills and be empowered to work to their full potential.

Starting in July 2026, the new Alberta Disability Assistance Program will become operational and disability income assistance applicants will be assessed for both the new program and AISH. Eligible applicants



will be placed in the program best suited to their unique situation. If deemed eligible for AISH or ADAP, applicants will receive the difference in benefits retroactively to the date that their complete application was submitted.

There will be a single combined application for AISH and ADAP, and an applicant's needs and situation will determine which program they are eligible for. In general, people with a permanent and severe disability who are unable to work will be eligible for the AISH program, while those with disabilities who are assessed as able to work will be eligible for ADAP. ADAP clients can apply for reassessment for AISH if their medical condition or ability to work changes.

All existing AISH clients will be assured a place in either the new Alberta Disability

Assistance Program or the AISH program. Those currently on AISH will continue to receive their existing benefits until they are able to be placed in the program best suited to their unique situation, and can rest assured that their care and wellbeing will be prioritized as the new program is

implemented. Benefit amount and duration. Benefit rates and earned income exemptions for ADAP are still being decided, and more information will be shared in the near future. Alberta provides some of the most comprehensive supports amongst the provinces for people with disabilities, and Alberta's government is committed to ensuring that the province continues to have the best disability programs in Canada.

There is no maximum program duration for ADAP - clients will receive supports for as long as they need. ADAP will provide higher earning exemptions than any other program, meaning Albertans on ADAP can earn more from working while continuing to receive their financial benefits. Monthly benefits will be gradually reduced as employment income increases.

The new program will include the same robust health benefits as AISH. Albertans on ADAP will be able to receive the health benefits they need, regardless of their employment income. Once a person reaches the

maximum earnings and is no longer eligible for monthly financial benefits, they will continue to be eligible for health benefits, up to age 65, when they transition to seniors' health benefit programs.

Through ADAP, Albertans with disabilities will not

only receive the financial and health benefits they rely on, but they also will have access to the resources and tools they need to gain new skills and work to their full potential.

To support this, Alberta's government will be investing more to expand employment supports and encourage private sector employers to break down barriers to employment for people with disabilities.

#### **Assured Income for the Severely Handicapped (AISH)**

The long-standing Assured Income for the Severely Handicapped (AISH) program will still be there for those with permanent and severe disabilities who are unable to work. As a legislated program, AISH will remain fully funded and available to all eligible Albertans.

Applications will continue to be processed to ensure eligible applicants receive benefits as soon as possible.

### Preparing for Tax Season

Tax season can feel overwhelming, especially when you're navigating disability-related benefits. Filing your income tax return on time is important, even if you have little or no income, as many federal and provincial benefits are based on your tax information.

#### Disability Tax Credit (DTC)

The Disability Tax Credit is a non-refundable tax credit that can help reduce the amount of income tax you owe and may make you eligible for additional benefits and programs. Many people are unsure if they qualify, or how to apply. VAD can provide information, guidance, and referrals to help you understand the process.

#### Why Filing Your Taxes Matters

Filing your taxes helps ensure you remain eligible for important benefits, including:

- Disability Tax Credit (DTC)
- Canada Disability Benefit (CDB)
- GST/HST Credit
- Canada Carbon Rebate
- Other federal and provincial income-tested programs

Even if you have no income, filing a return helps protect your access to these supports.

#### Free Tax Clinics with VAD

VAD offers free tax clinics for eligible individuals with disabilities. Our staff assist with basic tax returns and help connect you to additional supports if needed. Appointments are limited and fill quickly, so we encourage members to contact VAD beginning in March to schedule an appointment.

VAD's Tax season runs from April to May, and taxes can only be done by appointment in person. If you are unable to provide your T-slips, VAD can download them from the CRA for processing. VAD is able to do taxes from 2020 to 2024 VAD's FREE tax clinics are for low income individuals with simple taxes only.



## Community Inclusion Project

### Update on Indigenous & Multicultural Outreach

Voice of Albertans with Disabilities continues to strengthen relationships with Indigenous and multicultural communities across Alberta. Through community presentations, outreach meetings, and pop-up information sessions, VAD is working to reduce barriers and improve access to disability related information and supports.

Our outreach focuses on building trust, listening to community needs, and providing culturally respectful, accessible information. This includes offering plain-language resources, multilingual materials, and one-to-one support for individuals navigating programs such as AISH, CPP-Disability, the Disability Tax Credit, and the Canada Disability Benefit.

VAD remains committed to working alongside community partners to ensure people with disabilities from diverse cultural backgrounds feel welcomed, informed, and supported. Outreach activities will continue throughout the year, with additional community visits and collaborations planned.

### Language-First, Accessible Materials

VAD is committed to using language-first, accessible materials that respect individual identity, culture, and lived experience. We strive to share information in clear, plain language and offer materials in multiple formats whenever possible.

Our approach recognizes that language matters. Using respectful, inclusive wording helps reduce barriers, build trust, and ensure information is understandable and accessible to everyone. VAD continues to work with community partners to adapt resources so they are culturally appropriate, easy to navigate, and responsive to diverse communication needs.

VAD works to make information easy to understand and easy to access for everyone. We know that clear communication helps people feel more confident and supported when navigating disability-related services.

We do this by:

- Using plain language instead of technical or legal wording
- Providing translated materials when possible  
Using visuals, such as images and simple graphics to explain information
- Adding QR codes that link directly to forms, resources, and supports online

These approaches help reduce barriers, support different learning styles, and ensure people can access information in ways that work best for them.

### Culturally Respectful Support

VAD is committed to providing support that is culturally respectful, inclusive, and responsive to the diverse communities we serve. We recognize that experiences of disability are shaped by culture, language, family, and community, and that trust is built through listening and understanding.

Our team works alongside Indigenous and multicultural community partners to ensure supports are delivered with care, respect, and cultural awareness. This includes adapting communication styles, offering language-appropriate resources, and meeting people where they are—both literally and culturally.



By centering respect and relationship-building, VAD strives to create safe, welcoming spaces where individuals feel heard, supported, and empowered to navigate disability-related services.


